Dear Parishioners,

Our 4th year under Father Paveglio's leadership has been a year of investment; investment in sustainability. Incurring expenses of a new parking lot, new sound system and new staff I am pleased to report that the parish remains debt free.

With the changeover of our accounting system in the middle of fiscal year 2020, fiscal year 2021 brought a full year for the finance committee to utilize statistical analysis – Financial Dashboards, GAAP Compliant Statements and graphical interpretations - for the analysis of the monthly income, monthly expenses and forecasting and budgeting process. We ended close to budgeted target.

Inflation could be a concern, with many of our parishioners on a fixed income, church offertory could be negatively impacted. Additionally, labor and energy costs are our largest expenses impacted by inflation so, we may need to offset those additional costs. Catholic Schools Center of Excellence provided us with a list of Catholic Foundations for applicable grant funds. These foundations do require an invitation to apply. We have an individual within our community willing to write the grant application but have yet to solidify a connection between our parish and those of the Catholic Foundations.

School enrollment at capacity, ERTC monies received in the spring, new faces in the pews, and the 95% collection of the capital campaign monies all aided in our positive fiscal position.

Fiscal Year 2023 will bring the fruits of the Synod process, St. Vincent de Paul Conference, and Respect Life committee just to name a few. An "Adopt-A-Pledge" campaign will be announced shortly so we may reap the benefits of the last \$72,000 yet to be redeemed and call our capital campaign closed. The air conditioning system will place a short-term strain on our resources, but I am confident this community will step up as it always has.

This year I was joined by Andrea Krawczyk as co-chair of Saint Rose Finance Committee. Please welcome Andrea to this position and provide her all the support she may need.



## **Total Expenses**




2021 2023 Projected

### **Church Income**




## **Church Expense**




## **MINISTRY HIGHLIGHTS**







## NWEA Spring 2022 Assessment Results

Each school year students in Grade 2 to Grade 8 take the NWEA MAP (Measure of Academic Performance) assessments. Students participate in Math, Reading and Language use assessments. These tests give us a glimpse into our students, our curriculum and our teaching practices. From year to year we can see trends, areas of strength, and areas of growth. These assessments help us make changes directly in the classroom and at the school wide level.

The percentage below represents students' scores who met or exceeded their projected growth from the Fall of 2021, to the Spring of 2022.

Math = 41% Reading = 44% Language Use = 66%

## Action Step: Implement new extra-curricular clubs and activities

In 2021-2022 we were happy to have around 70 student athletes participating in Catholic Athletic Association sports teams. For many students, it was their first time participating in Saint Rose athletics. At a School Advisory meeting, additional offerings were discussed (economics club, chess club, art classes, etc.)



## Action Step: Research additional Catholic rituals that could be celebrated

The Catechesis of the Good Shepherd program was implemented in the Fall of 2021. With the help of outside resources, we were able to start the program for our Prekindergarten students. We are working on how to best implement this program going forward and are working with the parish staff, Archdiocese and others to find ways to best establish this program for the long-term growth of the program and Catholic Identity of the school.

Action Step: Provide all-school initiatives at the principal's discretion based on professional development topics and the current climate and needs of the school

Saint Rose developed a team of teachers that helped implement the Peace of Mind initiative that focuses on students' mental and social health needs. This program consisted of in person and zoom sessions that helped us implement the Nurtured Heart Approach, and we have a school counselor onsite one day per week.

#### Action Step: Execute class trip

In June of 2022, our Middle School students attended the first Washington DC trip for our school. This was the third attempt at going due to the pandemic. We are excited because our school was chosen to lay a wreath at the Tomb of the Unknown Soldier. We were so honored!



## Action Step: Include Professional Development funding for teachers

We continue to strive to provide funding for PD for teachers and staff. We have been fortunate enough to have funding from varying resources that allow the principal to help pay for teachers to attend PD activities.
